Hunter:

Admits live on Adams 2nd, asked his Resident Advisor (RA) for flyers to place on his floor. He knocked on resident's doors, asked all residents if they had voted, then encouraged them to vote and then vote for his campaign.

Hunter addressing Laura's complaint:

Dismissed Greg's complaint. Yes conversation happened but not the way it was submitted in the Grievance.

Brought to her attention by Greg and realized was against the Election Code. She wants to make election fair doesn't believe it was ill will. If the topic of Ten for Mason came up can change results of election.
